By now, **no one** should need to file BONUS, SEVRANCE, or any other issues with unemployment moving forward. If you think you should, PLEASE ask me first so we can try to keep payments moving as quickly as possible.

If you have not been paid for several weeks, PLEASE reach out to me at <u>sect@iatse478.org</u>.

If you are just opening a claim or restarting a claim (for various reasons). SAY NO to all SEVERANCE and PENSION questions.

If you have pulled funds from your annuity or you are receiving a grant. You DO NOT need to claim it on unemployment.

You are able to accept work. You should report those earnings on your weekly filing. Depending on how much you are going to be paid for the work (report when you work, not when you receive the check), you may not be paid unemployment for that week, however you should file a weekly every week. THIS GOES FOR ALL STATES!

Weekly Filings by the last number of your SSN – If you miss your day, you can file Wednesday to Saturday. This was implemented to ease up the number of people filing Sunday, Monday, and Tuesday. It seems to be working well and most people are being paid swiftly.

Overpayment Account Letters – If you received one of these letter, they should do an offset (deduct it from one of your weekly checks) to your benefits once the appeal period has passed. When they do the offset, you will see it in the Payment section at the bottom of your claim summary. You can send them a check if you wish, however, they do not have full staff at the offices, so make sure you make a copy of the check and the paperwork so if it does not get processed to your account, we can reach out to them.

They have to wait to do the offset until they make it past the appeal time period so that is why it is taking several weeks for those offsets to be posted. Below is what you will see in your Payment Summary.
